Take PA Turnpike East to Exit # 226/Carlisle
Take Route 11 North to I-81 North
Take I-81 North to Exit 69/Progress Avenue \* \*

### From Philadelphia, New Jersey and Delaware:

Take PA Turnpike West to Harrisburg East - Exit # 247
Take Route 283 North to Route 83 North/Route 322
Take Route 83 North/Route 322 to junction with I-81
Merge immediately into right lane
Follow I-81 South to Exit 69/Progress Avenue (exit on right) \* \*

### From Northeastern Pennsylvania and Central Upstate New York:

Take I-81 South to Exit 69/Progress Avenue \* \*

# From Northwestern Pennsylvania and Western Upstate New York:

Take I-80 East to Exit 123/Route 970
Take Route 970 South to Route 322 East
Take Route 322 East to Route 22-Route 322 East
Follow to I-81 interchange
Take I-81 North to Exit 69/Progress Avenue \* \*

#### From Lancaster 283 West/or from York 83 North:

Take 83 North to I-81 South. Take Exit 69/Progress Avenue\*\*

\* \* At bottom of exit ramp, turn left on Progress Avenue. Travel North on Progress Avenue to second traffic light at Paxton Church Road. Immediately after the light at Paxton Church Road (next road) turn right on Vartan Way. Go around the bend to the left and the building is on your right.
